### **CHIEF'S REPORT**

### Alarms:

For August 2023, the District responded to 51 Aid calls, 14 Medic calls, 28 Fire calls, and 12 service calls for 105 total calls. The year-to-date total is 601 compared to 660 in 2022.

Turn-out times: August – The turn-out time standard was achieved on 55 of 95 calls, which was 57.9%. The 90 percentile turn-out time was 2:15

- Five of our calls were MIH calls handled by Redmond Fire.
- Three of our calls were handled by Eastside Fire Rescue due to us on other calls.

# Volunteer Firefighters / E-Shift Program:

- The Volunteers completed 300 hours of E-Shift duty for July.
- Recruit Drake Hutchason, after consideration, decided to leave our program.
- I want to thank Firefighters Montefusco, Magnan, and Hansen for joining us at the 9/11 Ceremony yesterday.

#### **Career Staff:**

- Firefighters Brookshear, Fleming, and McKinnon will undergo Lieutenant Promotional Testing on September 28 at the SKCFTC. They will go through a Tactical, Oral Resume, Impromptu Role Play, and a Short Prep Presentation. I want to wish each of them good luck with their testing.
- Firefighter Lussier had an off-duty injury where he tore his pectoral muscle. We have moved him
  to a day-shift schedule, and he may be out for up to six months. I want to thank DC Ledoux and
  Melinda for the leg work on working with Greg on Family Medical Leave and Disability Leave.
- Because of Firefighter Lussier's injury, we implemented the 6-19 schedule and moved Firefighter Conroy and Hillier to that schedule. This will also help since Firefighter Hillier may also go on leave when his baby is born at the end of the month.
- For the next few weeks, we will not deploy any wildland apparatus due to the promotional and schedule changes.
- I want to thank B-Shift for their hard work outfitting the new Aid-Car.
- A-shift was part of a move up to Bellevue last month during one of their 3-alarm fires. They
  helped provide coverage within the City of Bellevue and ran two calls during their move-up. DC
  LeDoux was one of the Ops Chiefs who helped with all the move-ups within Zone 1 during both 3alarm fires last month.
- We will start the process of the possible hiring of the additional firefighter, through Public Safety Testing, pending the levy passing.

## Training:

- Career staff will be involved in MCO training on vehicle extrication this month.
- Staff attended some MCO training last month in Snoqualmie and within Fall City.
- DC LeDoux is at the King County Fire Chiefs Leadership Summit in Suquamish.

# Station/Equipment Projects:

- The WSRB evaluation was held on August 15. We are still providing some information to them if needed and look forward to receiving our draft rating in the near future.
- Aid 152 was taken to Evergreen Ford due to the EGR Cooler going out.
- Engine 152 went into the shops for a week for annual preventive maintenance. It will have to go back when additional parts come in. There were some concerns with the suspension system; they will replace the shocks on the Engine and complete the PM after.
- The District received three new computers from King County EMS that will be used for EMS reporting.
- DC LeDoux and I are looking at options on a Wildland Skid Unit or a Brush Truck for the District.
- We had a water leak from the HVAC system above the training room. We are working with insurance to get repairs completed as soon as possible.
- The new A-152 is almost complete and should be placed into service later this week or early next week. We will hold a housing ceremony in the near future, and we will invite the community.
