Oath of Office

APPROVAL OF MINUTES:

On the Motion of Chairman Meredith and a second by Commissioner Hansen, the Board approved the Minutes of the November 14, 2023 Regular meeting and November 28, 2023 Special meeting. MOTION CARRIED.

WARRANTS:

Chief Culp briefed the Board on the warrants and EFT transactions presented for payment.

FINANCIAL REPORTS:

2023 Budget and Bond Fund Report

The Board reviewed the Monthly Budget, Bond Report and Financial Statements. The Board discussed moving funds into the Apparatus Reserve line item.

On the Motion of Commissioner Belfield and a second by Commissioner Hansen, the Board transferred \$80,000 from the Cash line item to the Capital Reserve-Apparatus line item. MOTION CARRIED.

CORRESPONDENCE:

CHIEF'S REPORT:

Alarms:

For November 2023, the District responded to 29 Aid calls, 12 Medic calls, 24 Fire calls, and three service calls, a total of 68 calls. The year-to-date total is 827 compared to 936 in 2022.

Turn-out times: November - The turn-out time standard was achieved on 28 of 65 calls, which was 43.1%. The 90 percentile turn-out time was 2:24.

- One call was an MIH call handled by Redmond Fire.
- Eastside Fire Rescue handled one call due to us on another call.

Volunteer Firefighters / E-Shift Program:

- The volunteers completed 233 hours of E-Shift duty for October.
- Firefighter Michael Larson was removed from the membership roster
- Firefighter Connor Portugal has resigned as he will start with Puget Sound Fire at the beginning of next year.

Career Staff:

- The career staff will have changes to their shifts starting in January. I want to thank the career staff for conducting their vacation and Kelly Day bidding for 2024.
- Firefighter Lussier is still on light duty and may be able to return to full status around February 1.
- DC LeDoux is working on pulling together applications for the open firefighter position. We aim to start looking at interviews around the first of the year.
- Firefighter Jake Conroy had his first field delivery on November 18. Captain Fleming, Firefighter McKinnon, and Vol Firefighter Geller supported the delivery. Bellevue Medic 1 transported the Mother and infant daughter to the hospital.

Training:

- Captain Fleming, Firefighter Noble, and Fleming attended the Pump Academy in Renton from November 27 to December 8.
- Lieutenant Bandy returned from the National Fire Academy after taking a leadership supervision course.
- DC Ledoux is working with SKCFTC on bringing Captain Fleming up to date for next year when Captain Fleming moves to the Day Shift Officer. Chief Culp discussed the Training Consortium's new policy that will provide compensation for any extra training classes that are taught by the Instructors.
- Paramedic Brandon Bothwell from Bellevue provided three days of EMS Training to the three shifts.
- Bellevue Medics also provided BLS/ALS interaction training with the crews.
- Firefighters Fleming and Dumas will attend a wildland engine boss class in December.

Station/Equipment Projects:

- Melinda has been working with King County and US Bank to assemble one of the last parts for our EMS transport billing. I want to thank Melinda for her hard work on this project. We may be delayed on the start of our billing process as we are still setting everything up.
- We finally received notice that we did not receive the FY22 AFG Grant. We will continue to look at outside funding sources for projects to reduce the impact on the general fund.
- The Engine Committee met yesterday to discuss the specs for a new engine. Chief Culp
 discussed the price increases that will go into effect on January 1, 2024. He discussed the
 estimated costs and delivery timeline that could be expected. The Board discussed scheduling
 a special meeting to review the options further.
- A-252 was evaluated for an electrical problem with the patient's compartment.
- Hughes Equipment is working on ordering the needed items to repair the minor damage to Aid-152.
- DC LeDoux is working with other agencies regarding a future agreement on vehicle maintenance.
 We hope to have something to present to the Commission within the next few months.
- Engine 252 is out of service after going to the pump academy. While at the pump academy, it
 was having trouble shifting into pump mode. EFR Shops are aware and have ordered the needed
 parts.
- The SCBA Compressor is out of service due to the CO monitor not calibrating. This is the second time this year that this has occurred.
- Brush 152 had its siren box replaced.

The Union LOCALS will merge and it is fire service tradition for the merged LOCAL to take the lowest LOCAL number. LOCAL 2878 will now be LOCAL 1762.
