## **CHIEF'S REPORT:**

#### Alarms:

- For July 2025, the District responded to 44 aid calls, 22 medic calls, 33 Fire calls, and 12 service calls, for 111 calls. The year-to-date total is 581 compared to 590 in 2024.
- Turn-out times: July The turn-out time standard was achieved on 74 of 104 calls, which was 71.2%. The 90th percentile turn-out time was 1:57.
- Redmond Fire went to three MIH calls.
- EFR responded to one Aid call while we were on another incident.
- In July, we transported 23 patients to the hospital.

## Volunteer Firefighters / E-Shift Program:

• 36 hours of E-Shift duty for July.

#### Career Staff:

- Last month was a busy month for the crews, but they were still able to achieve a lot of training during the month.
- I want to thank the crews on filling shifts. Everyone has been great about picking up shifts.
- Our two new recruits started on 08/11/2025; they will be here at the station for a few days before
  they are assigned to the EFR Recruits. EFR will be working with them until the start of the Recruit
  Academy at the end of the month. This will allow them to begin obtaining some of the necessary
  pre-training set and reps to be successful.
- Captain Fleming will be assigned to the SKCFTC for the next recruit academy. This will also allow him to oversee the success of our recruits.
- Congratulations to Firefighter Patterson on getting married last month.

## **Training:**

 EFR and Fall City are working together to talk to the SKCFTC on a change in training regarding Swiftwater and Rescue Swimmer courses. Some of the staff are asking for Rescue Swimmer Certification because of the nature of our calls. Currently, both are different courses, but there is a lot of similarity in the training.

## Station/Equipment Projects:

- The five new computers have been set up and are in service.
- The crews were able to complete hydrant inspections last month.
- Engine 252 is at the Shoreline shops for its annual service and pump test.
- The Shoreline Shops evaluated the Brush Truck that is being decommissioned by EFR. We are working with EFR to possibly obtain this unit.
- A new light tower has been installed on the boat. This will increase the safety of the crews during night calls. The tower is hinged so that it fits into the trailer. I want to thank the crews for installing this on the boat.
- I want to thank Captain Fleming for going to Spokane to pick up the two new ladders.
- Melinda has scheduled the floors to be cleaned on August 16.

## **Community Projects/Events:**

- The District has applied for the permit with King County to place the Fire Danger sign in the Lake Alice area. It is under their review at this time.
- The District hosted National Night Out on August 5. It was successful, and both the Sheriff's Department and Fire District were able to hang out with the Community and cook some hot dogs.

## **UNFINISHED BUSINESS:**

## **Contracting for Services Discussion**

Chief Culp reported that he and Chairman Meredith had met with Chief Lane to discuss some preliminary considerations on each agency's expectations. Chief Lane had discussed EFR's current capacity within their finance department and fleet operations. They would need to hire another technician to take on the District's apparatus maintenance and additional resources would be needed for administrative operations. They also discussed the succession of EFR's next Fire Chief, which will be announced in September.

Chairman Meredith stated that the discussion went well and Chief Lane conveyed their success with previous contracts was the relationship building they had prior to establishing their agreements. Chief Lane had also discussed some of the current challenges they are experiencing and certain issues with equalizing revenues from the distinct types of government taxing structures, with cities being different from fire districts.

Commissioner Belfield inquired if the District's next step was a more formal approach, as with an RFP to their Board. Chief Culp and Chairman Meredith conveyed that the process and discussion could remain informal at this time while EFR gets through their hiring process for their new Fire Chief.

Further discussion ensued on the District's long-term financial stability, new engine purchase and staffing stabilization.

After discussion, the Board stated that getting some additional financial information on shared costs of a deputy chief position would be desired. Chief Culp also noted that EFR is currently in negotiations with their firefighter's collective bargaining agreement.
